- This clinic is to improve your understanding of the role as an R2 and working with the R1.
- This is a clinic that will be 80% round table discussion with some on court demonstrations to help understand where the R2 is to be positioned before and during the game.
- Learning tips and tricks to using a line up card
- How to know who is front row and who is a back row player
- Illegal alignments and how to spot them.
- Officials hand signals, mirroring the R1 and the proper procedures for making net calls.
- Working with your table workers and understanding the scorebook and the R2's responsibility for the accuracy of what is in the book.

- This clinic will be using the 2024/2025 rule book as your workbook. Knowing what is in your rulebook and where to find the answers to situations that arise.
- Pages from Referee, Net Gain, Officiating Volleyball's Tough Calls Book.
- We all come from different areas of the state and work different levels of competition. By using the resources of your fellow officials to learn how they use a line up card or how they keep track of back row setters and back row attacks.
- Being able to ask how other officials handle difficult coaches, or what to do in situations that may have arisen in past seasons.
- What to do if your line judges or table workers, are not doing the job or have not been trained properly.
- Understanding a libero tracking sheet and what to do if there is no libero tracker.
